

Deductible and Coinsurance Waived for Certain Preventive Services

- For DOS on or after 1/1/2011
 - Medicare deductible and coinsurance waived for preventive services included in this presentation
 - <u>CR 7012</u>, "Waiver of Coinsurance and Deductible for Preventive Services, Section 4104 of Patient Protection and Affordable Health Care Act, Removal of Barriers to Preventive Services in Medicare"





Did You Know...

 A beneficiary must be enrolled in Medicare Part B to be covered for any Medicare preventive services





STI Screening

Did You Know

STIS

- Passed from one person to another through sexual contact
- Many STI-infected people do not have symptoms so do not always seek out medical attention
- Can cause significant health complications if untreated
- Medicare coverage of STI screening not based on presence of symptoms





Benefits of STI Screening

- Early detection of STI
- Decrease in spread of disease/infection
- Reduction in HIV transmission
- Assists medical community in identifying trends, gathering data





Background

- Medicare covers screening for four specific STIs
 - Chlamydia
 - Gonorrhea
 - Syphilis
 - Hepatitis B
- Effective for DOS on/after 11/8/2011

- Performed by primary care practitioner
 - NP
 - CNS
 - PA

Approved Facility Types

- Hospital outpatient
 - Using TOB 13X
- Hospital nonpatient laboratory specimens
 - Using TOB 14X
- CAH
 - Using TOB 85X with revenue code 096X, 097X or 098X





Documentation and Billing Guidelines

- Documentation must show all coverage requirements met
 - Identify applicable risk factor(s)
- Claim should report
 - ICD-10 diagnosis codes
 - Appropriate revenue code
 - CPT code





High-/Increased-Risk Behaviors

- Multiple sex partners
- Using barrier protection inconsistently
- Sex under the influence of alcohol or drugs
- Sex in exchange for money or drugs
- Having an STI within the past year
- Men having sex with men and engaged in high-risk sexual behavior





Screening for Chlamydia – Coverage Requirements and Frequency

- Pregnant women who are 24 years old or younger or at increased risk for STIs
 - Covered up to twice per term
 - \checkmark When pregnancy is diagnosed
 - \checkmark Repeated during third trimester if high-risk sexual behavior continued
- Women at increased risk for STIs
 - Covered annually





Screening for Chlamydia – Diagnosis Codes

- Report Z11.3 and one of the following
 - Z72.51 (High-risk heterosexual behavior)
 - Z72.52 (High-risk homosexual behavior)
 - Z72.53 (High-risk bisexual behavior)
 - Z72.89 (Other problems related to lifestyle)
- For pregnant women at increased risk, also report applicable code from "Additional ICD-10 Diagnosis Codes" slides





Screening for Chlamydia – CPT Codes

- Report one of the following
 - 86631 Antibody; Chlamydia
 - 86632 Antibody; Chlamydia, IgM
 - 87110 Culture, chlamydia, any source
 - 87270 Infectious agent antigen detection by immunofluorescent technique; Chlamydia trachomatis
 - 87320 Infectious agent antigen detection by immunoassay technique, qualitative or semi-quantitative, multiple-step method; Chlamydia trachomatis





Screening for Chlamydia – CPT Codes

- 87490 Infectious agent detection by DNA or RNA; Chlamydia trachomatis, direct probe technique
- 87491 Infectious agent detection by DNA or RNA; Chlamydia trachomatis, amplified probe technique
- 87810 Infectious agent antigen detection by immunoassay with direct optical observation; Chlamydia trachomatis
- 87800 Infectious agent detection by DNA or RNA, multiple organisms; direct probe(s) technique

\checkmark Use when performing combined chlamydia and gonorrhea testing





Screening for Gonorrhea – Coverage Requirements and Frequency

- Pregnant women who are 24 years old or younger or at increased risk for STIs
 - Covered up to twice per term
 - \checkmark When pregnancy is diagnosed
 - \checkmark Repeated during third trimester if high-risk sexual behavior continued
- Women at increased risk for STIs
 - Covered annually





Screening for Gonorrhea – Diagnosis Codes

- Report Z11.3 and one of the following
 - Z72.51 (High-risk heterosexual behavior)
 - Z72.52 (High-risk homosexual behavior)
 - Z72.53 (High-risk bisexual behavior)
 - Z72.89 (Other problems related to lifestyle)
- For pregnant women at increased risk, also report applicable code from "Additional ICD-10 Diagnosis Codes" slides





Screening for Gonorrhea – CPT Codes

- Report one of the following
 - 87590 Infectious agent detection by DNA or RNA; Neisseria gonorrhoeae, direct probe technique
 - 87591 Infectious agent detection by DNA or RNA; Neisseria gonorrhoeae, amplified probe technique
 - 87850 Infectious agent antigen detection by immunoassay with direct optical observation; Neisseria gonorrhoeae
 - 87800 Infectious agent detection by DNA or RNA, multiple organisms; direct probe(s) technique*





Screening for Syphilis – Coverage Requirements and Frequency

Pregnant women

- Covered up to three times per term
 - \checkmark When pregnancy is diagnosed
 - ✓ Up to two additional screenings, as ordered during third trimester and at delivery if highrisk sexual behavior continued
- Men and women at increased risk for STIs
 - Covered annually





Screening for Syphilis (Pregnant Women) – Diagnosis Codes

- Report Z11.3 and one of the following
 - Z72.51 (High-risk heterosexual behavior)
 - Z72.52 (High-risk homosexual behavior)
 - Z72.53 (High-risk bisexual behavior)
 - Z72.89 (Other problems related to lifestyle)
- For pregnant women at increased risk, also report applicable code from "Additional ICD-10 Diagnosis Codes" slides





Screening for Syphilis (At Increased Risk) – Diagnosis Codes

- Report Z11.3 and one of the following
 - Z72.51 (High-risk heterosexual behavior)
 - Z72.52 (High-risk homosexual behavior)
 - Z72.53 (High-risk bisexual behavior)
 - Z72.89 (Other problems related to lifestyle)
 - Applicable code from "Additional ICD-10 Diagnosis Codes" slides





Screening for Syphilis – CPT Codes

- Report one of the following
 - 86592 Syphilis test, non-treponemal antibody; qualitative (eg, VDRL, RPR, ART)
 - 86593 Syphilis test, non-treponemal antibody, quantitative
 - 86780 Antibody; Treponema pallidum





Screening for Hepatitis B – Coverage **Requirements and Frequency**

Pregnant women

- Covered up to twice per term for pregnant women
 - ✓ At first prenatal visit
 - Repeated at time of delivery if high-risk sexual behavior continued
- Asymptomatic, non-pregnant women and men at risk for HBV infection
 - Covered once in lifetime
 - Annual screening if continued high risk behavior without vaccination
 - ✓ Additional high-risk factor: IV drug use





Screening for Hepatitis B (Pregnant Women) – Diagnosis Codes

- Report Z11.59 and one of the following
 - Z34.00 (Encounter for supervision of normal first pregnancy, unspecified trimester)
 - Z34.80 (Encounter for supervision of other normal pregnancy, unspecified trimester)
 - Z34.90 (Encounter for supervision of normal pregnancy, unspecified, unspecified trimester)
 - 009.90 (Supervision of high-risk pregnancy, unspecified, unspecified trimester)





Screening for Hepatitis B (At Increased Risk) – Diagnosis Codes

- Report Z11.59
- Also report Z72.89 (other problems related to lifestyle) and one of the following
 - Z72.51 (High-risk heterosexual behavior)
 - Z72.52 (High-risk homosexual behavior)
 - Z72.53 (High-risk bisexual behavior)
- Also report applicable code from "Additional ICD-10 Diagnosis Codes" slides





Screening for Hepatitis B – CPT Codes

- Report one of the following
 - 87340 Infectious agent antigen detection by immunoassay technique, qualitative or semi-quantitative, multiple-step method; hepatitis B surface antigen (HBsAg)
 - 87341 Infectious agent antigen detection by immunoassay technique, qualitative or semi-quantitative, multiple-step method; HBsAg neutralization

Payment

- Hospitals paid based on OPPS
- CAHs paid based on reasonable cost
- Deductible/coinsurance/copayment waived
 - Affordable Care Act Section 4104





Why Claims Are Denied

- Beneficiary received additional screening within frequency limitations
- Screening not performed in appropriate setting





High Intensity Behavioral Counseling to Prevent STIs

HIBC to Prevent STIs

- Effective for DOS on or after 11/8/2011
- Benefits of HIBC
 - Decrease in spread of disease/infection
 - Assist beneficiary with knowledge and information so they can make lifestyle changes and take precautions to avoid infectious disease and prevent future exposure

Approved Facility Types

- Hospital non-patient laboratory specimens
 - Using TOB 14X
- RHCs (additional billing instructions)
 - Using TOB 71X with revenue code 052X
- FQHCs (additional billing instructions)
 - Using TOB 77X with revenue code 052X
- CAHs
 - Using TOB 85X with revenue code 096X, 097X or 098X





HIBC to Prevent STIs – Coverage Requirements and Frequency

- Sexually active adolescents and adults at increased risk for STIs
 - Up to two, individual, 20- to 30-minute, face-to-face sessions covered annually
 - \checkmark One session covered on any one DOS
- HIBC sessions must include
 - Education
 - Skills training
 - Guidance on how to change sexual behavior





High-/Increased-Risk Behaviors

- Multiple sex partners
- Using barrier protection inconsistently
- Sex under influence of alcohol or drugs
- Sex in exchange for money or drugs
- 24 years of age or younger (for women for chlamydia and gonorrhea)
- Having an STI within the past year





High/Increased Risk Behaviors

- IV drug use (for hepatitis B only)
- Men having sex with men and engaged in high-risk sexual behavior (no age requirement)





Documentation

- Documentation must show all coverage requirements met
 - Indicate high/increased risk
 - Indicate components provided





HIBC for STI Billing Guidelines

- ICD-10 diagnosis code Z72.89 (other problems related to lifestyle)
- Appropriate revenue code
- HCPCS code G0445 (HIBC to prevent STIs, face-to-face, individual, 30 minutes)





Additional Billing Instructions for RHCs and FQHCs

- HIBC to prevent STIs qualifies as stand-alone billable encounter
 - Report as billable encounter using billable encounter revenue code 052X
 - ✓ FQHCs report appropriate payment code line; report HIBC as qualifying visit HCPCS code line
 - Generates AIR/PPS payment
- If performed on DOS as another billable encounter, report as incident to service





Payment

- Hospitals paid based on OPPS
- CAHs paid based on reasonable cost
- RHCs and FQHCs paid/payment included in AIR/PPS encounter rate
- Deductible/coinsurance/copayment waived
 - Affordable Care Act Section 4104





Why Claims Are Denied

- Beneficiary received additional counseling within frequency limitations
- HIBC not performed in appropriate setting


